

# Summary of Application Guidelines for the University Recommended Japanese Government (MEXT) Scholarship for Research Student in 2024 (Draft)

## 1. Qualification

1) **Nationality:** Applicants must have nationality of a country that has diplomatic relations with the Japanese government.

※ Applicants from the countries specified by MEXT are given priority. Please refer to the list of priority countries.

2) **Age:** Applicants must be born on or after April 2, 1989.

3) **Eligibility for enrollment in Graduate School:** Applicants must have the necessary qualifications to be admitted to graduate school.

[1] Those who have completed 16 years of school education in a foreign country (18 years for admission to a doctoral program in medicine), including those who are expected graduation.

[2] Those who have reached the age of 22 (24 for admission to the doctoral program of medicine) and recognized as having academic ability equal to or higher than that of university graduates by individual entrance qualification screening at the graduate school, including those who are expected graduation.

(Note) Includes those who are qualified to enter a Japanese graduate school with qualifications other than the above (including those who are expected graduation).

4) **Language proficiency:** Applicants must be proficient in English or Japanese language and meet one of the following conditions:

### 【Japanese】

[1] Passed JLPT N2 or higher at the time of enrollment.

[2] Completed the curriculum that meets the entrance qualifications for the doctoral program in Japan, with Japanese as the main language.

[3] Have competency equivalent to [1]

### 【English】

[1] Have an English proficiency test score of CEFR B2 level or higher at the time of enrollment.

[2] Completed the curriculum that meets the entrance qualifications for the doctoral program in Japan, with English as the main language.

[3] Have competency equivalent to [1]

5) **Arrival in Japan:** Applicants must, in principle, be able to arrive in Japan by a date specified by the accepting university which should be within two weeks before or after the first day of the semester (October 1) .

6) **Academic Score:** Applicants who have already graduated from their latest degree program must have a final grade point of 2.30 or higher out of 3, while current students must have a grade point of 2.30 or higher for their current courses, and both are expected to maintain the same academic standards during the period of the scholarship program.

## 2. Scholarship benefits

MEXT covers the entrance examination fee, the entrance fee and the tuition fee.

About 150,000 yen monthly stipend will be given to each grantee during the period of graduate school enrollment and the period of enrollment as a research student (scholarship for research student lasts up to one and a half years), however the scholarship will be suspended if the grantee's academic performance is significantly poor.

## 3. Non-eligibility

Those who meet any one of the following conditions are ineligible. If identified ineligible after being selected as a scholarship student, he/she must withdraw from the scholarship.

- 1) Those who are military personnel or military civilian employees at the time of their arrival in Japan or during the period of the payment of the scholarship.
- 2) Those who cannot arrive in Japan by the last date of the period specified by MEXT or the accepting university;
- 3) Those who are previous grantees of Japanese Government (MEXT) scholarship programs (including those who withdraw from the scholarship program after the arrival in Japan). This does not apply to: those who have educational or work experience exceeding more than three years from the following month of the period of the previous scholarship to the estimated first month of the payment of this scholarship; and the past grantees of Japanese Studies Students program who have graduated or are going to graduate from universities in their home countries, Japan- Korea Joint Government Scholarship Program for the Students in Science and Engineering Departments and Young Leaders' Program. The Monbukagakusho Honors Scholarship for Privately-Financed International Students is not included in the Japanese Government (MEXT) Scholarship Programs and its recipients are eligible.
- 4) Those who are currently also applying to another program under the Japanese Government (MEXT) Scholarship system for which scholarship payments will begin in FY2024.
- 5) Those who are already enrolled in a Japanese university or other institution with a residence status of "Student," or who are going to be enrolled, or plan to enroll, in a Japanese university or other institution as a privately-financed international student from the time of application to the MEXT scholarship program until the commencement of the period for payment of the MEXT scholarship.  
However, this stipulation does not apply to privately-financed international students who, even though they are enrolled, or are planning to enroll, in a Japanese university or other institution, verifiably return to their home country at the time of the scholarship application, and newly acquire the "Student" residence status and come to Japan.
- 6) Those who are planning to receive scholarship money from an organization other than MEXT (including a government organization of the applicant's country) on top of the scholarship money provided by MEXT after the start of the scholarship payment period.
- 7) Those who are expected to graduate at the time of application and cannot satisfy the condition of academic background by the deadline given.
- 8) Holders of dual nationality at the time of application who cannot verify that they will give up Japanese nationality

by the time of the arrival in Japan.

- 9) Those who plan to, from the time of application for the MEXT scholarship program, engage in long-term research (such as fieldwork or internship) outside Japan or plan to take a long-term leave of absence from the university.
- 10) Those who have no intention to enroll in a regular course and, for a doctoral course, who do not plan on obtaining a degree.
